This matter comes before the Court on the parties' December 24, 2009 joint unopposed motion for entry of judgment and award of agreed amount of attorneys' fees. The Court, being fully advised in the premises, now ENTERS JUDGMENT AS FOLLOWS:

1. Judgment is hereby entered in favor of Plaintiff, Colorado Ethics Watch and against Defendant, Colorado Independent Ethics Commission, on Plaintiff's second claim for relief. Plaintiff's first claim for relief has already been dismissed with prejudice by order of this Court dated November 10, 2009.
2. Defendant's Advisory Opinion 09-04 is hereby declared invalid pursuant to C.R.S. section 24-6-402(8).
3. Pursuant to C.R.S. § 24-6-402(9), Ethics Watch is entitled to an award of attorneys' fees as prevailing party. The parties have agreed to an award in the amount of
